Political Signs Placement Regulated

October 1, 2011- New State Law: NCGS §136-32 Regulation of Political Signs

With the local elections in full swing, you have probably observed quite a few “vote for me” signs along the roadways and highways. Effective October 1, 2011, new laws went into effect:

(b) Regarding the place-

ment of political signs, beginning the 30th day before the beginning date of “one-stop” early voting under the statute, and ending on the 10th day after the primary or election day, political signs may be placed in the right-of-way of N. C. State Highways.

(c) A “political sign” is defined as any sign that advocates for political action,

and doesn’t include commercial signs.

(d) The person placing the sign must obtain permission from any business, residence or religious institution fronting the right-of-way where a sign may be erected.



Law Update

Just a few new Statutes that have recently become effective.

Medical Malpractice - N.C. Gen. Stat §90-21.19 Liability limit for noneconomic damages

Effective October 1, 2011, a \$500,000 cap has been placed on “non-economic damages” that patients can collect in a medical malpractice claim. Non-economic damages include pain, suffering and injuries. Medical bills, lost wages and other types of monetary losses are not included

in this cap.

In addition to the cap, a jury is required to use a higher standard of proof when determining negligence for emergency conditions.

Illegal Immigrant Employment – N.C. Gen. Stat. §64

NC is taking steps to prevent illegal immigrants from obtaining jobs in the City and County governments. The government agencies are now directed to use the E-Verify system to check the legal status of

applicants. The Verify requirement is to be implemented for larger NC companies in 2012 and smaller companies in 2013.

Sports – N.C. Gen. Stat. - §14-159.6 and 14-159.10

For all the hunters and fishermen out there: if you are hunting or fishing on land that has no trespassing signs or stripes of purple paint on the trees you must carry written permission slips signed by the landowner or you can be cited immediately by a Wildlife Agent.

way of a fully controlled access highway.

(2) No sign shall be closer than three feet from the edge of the payment of the road.

(3) No sign shall obscure

motorist visibility at an intersection.

(4) Signs may not be higher than 42" above the edge of the road pavement.

(5) The sign must be 864 square inches or less in size.

(6) No sign shall obscure or replace another sign.

(e) It's a class 3 misdemeanor for a person to steal, deface, vandalize or unlawfully remove a political sign that is lawfully placed under this section.
