Eliminating the following areas from the Substantive Law Section: Administrative Law, Bankruptcy, Criminal Law & Procedure, Estates and Probate, Family Law and Real Estate.

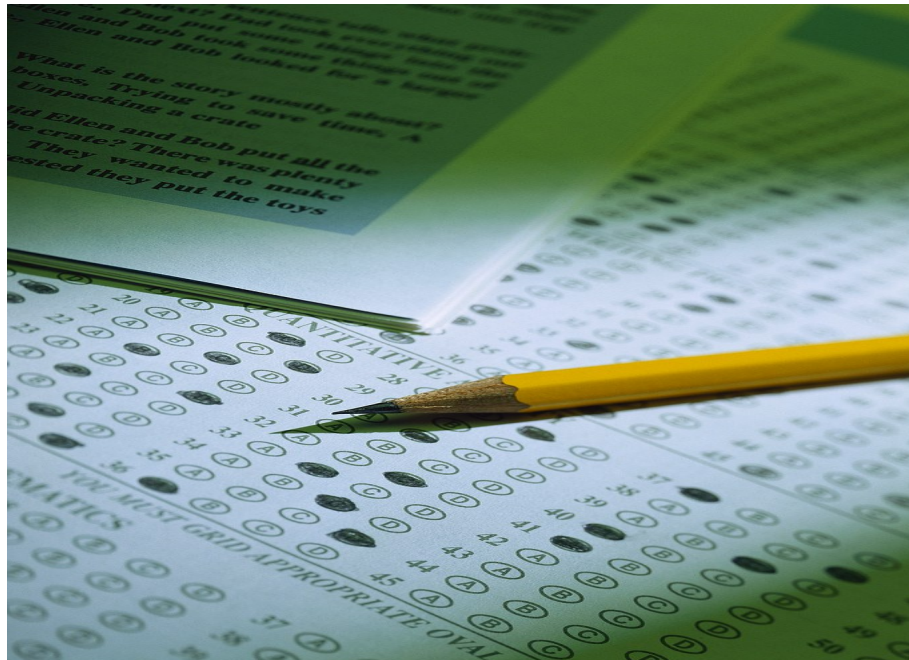
Making the Substantive Law section the same test for all examinees.

The Substantive Law Section will be comprised of questions on the American Legal System, Civil Litigation, Contracts and Business Organizations.

Must pass five parts and their total points are:

Lynn Price Memorial Scholarship at WPCC

After months of planning and background work, the Catawba Valley Paralegal Association (CVPA) Paralegal Scholarship was officially established on June 7, 2013. CVPA Community Outreach committee member Betty Winstead met at the Law Offices of Blair E. Cody, III with Atticus Simpson, Vice-President for Student Development at Western Piedmont Community College to finalize details. After our June 7th meeting, sadly, one of the founding members of CVPA, Lynn Price, passed away on July 16, 2013. The Board of Directors decided to re-name the scholarship to honor and remember Lynn.

This scholarship is established to assist 2 full-time paralegal students at WPCC with the cost of textbooks and supplies. One \$1,000 scholarship will be funded by CVPA per academic year*, in increments of two \$500 scholarships. CVPA has funded the first \$500 scholarship, with the next funding to occur later in 2013. Exact timing will depend on the availability of funds, donations received, and other considerations by the CVPA Board of Directors. *Whether or not the scholarship will continue beyond the 2013-2014 academic year will be determined by the 2013-2014 CVPA Board of Directors.

The awards will be authorized by the Executive Director of the Western Piedmont Foundation and Director of Financial Aid, as recommended by the WPCC Financial Aid Subcommittee. The first \$500 scholarship will be presented by Western Piedmont Foundation, Inc. this summer for use during the 2013 fall semester. Scholarship award guidelines include that timely application must be made by the applicant to the Financial Aid Office by the deadline each year. Applicants must maintain satisfactory academic progress standards, and be enrolled in the Associate Paralegal Technology degree program at WPCC. Part of the application process is the completion of a personal essay concerning the paralegal profession, with the exact topic to be decided and selection of winning essay to be judged by a panel of judges selected by WPCC. Applicants must have completed a minimum of 24 credit hours toward the degree. A minimum GPA of 3.5 is required, and preference

will be given to those who demonstrate active participation in the WPCC community activities, including campus activities and community involvement. Recipients of the CVPA scholarship are highly encouraged to attend a spring meeting of CVPA.
